- ii. You must make a claim under the warranty within ONE (1) Year from the date of purchase as printed on your receipt or invoice.
- iii. You will be required to return the defective product along with your proof of purchase, an additional payment of \$24.95 (dryers or irons) to cover the costs of shipping and handling.

THIS WARRANTY DOES NOT COVER: (1) Damage due to misuse or abuse, such as incorrect voltage supply, dropping, or failure to follow instructions enclosed in Product's packaging; (2) tampering, such as repair or attempted repair of the Product; (3) alteration or modification of the design, mechanics, or features of the Product. In the event of any misuse of the Product, you acknowledge and agree that you waive any claim of warranty and further agree that Argan Woman will not be liable to any damages you may suffer due to your misuse of the Product.
